1. Aims

This policy statement aims to set out our school's arrangements for managing the access of education and training providers to students for the purpose of giving them information about their offer.

It sets out:

- Procedures in relation to requests for access
- The grounds for granting and refusing requests for access
- Details of premises or facilities to be provided to a person who is given access

2. Statutory requirements

Schools are required to ensure that there is an opportunity for a range of education and training providers to access students in years 8 to 13 for the purposes of informing them about approved technical education, qualifications or apprenticeships.

Schools must also have a policy statement that outlines the circumstances in which education and training providers will be given access to these students. This is outlined in section 42B of the Education Act 1997.

In accordance with the Baker Clause, all maintained schools and academies must provide six encounters with a provider of technical education or apprenticeships for year 8 to 13 pupils. Mulberry Academy Shoreditch provides two such encounters before GCSE options choices are made in Year 9, two in KS4 before students make their post-16 choices and two across KS5, prior to final public exams.

In Sixth Form, all pupils are able and encouraged to attend the encounters, however, optional attendance for KS5 pupils recognizes that, while many 16-to-18-year-olds will benefit from finding out more about post-18 technical options, some sixth form students will have already made a firm decision to pursue their chosen pathway.

This policy shows how our school complies with these requirements.

3. Student entitlement

All students in years 7 to 13 at Mulberry Academy Shoreditch are entitled to:

- Find out about technical education qualifications and apprenticeship opportunities, as part of our careers programme which provides information on the full range of education and training options available at each transition point
- Hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships
- Understand how to make applications for the full range of academic and technical courses

4. Management of provider access requests

4.1 Procedure

4.3 Granting and refusing access

Access to students and/or parents will be granted on the understanding that information and guidance offered by providers is related to technical courses and apprenticeship opportunities only.

4.4 Safeguarding

Providers will be expected to meet the school's safeguarding requirements which can be found in the Child Protection and Safeguarding policy accessible on the school website.

4.5 Premises and facilities

The school will make the main hall, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The school will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of the relevant team.

Providers are welcome to leave a copy of their prospectus or other relevant course literature at the school. The Careers Leader will ensure that students have access to these materials at suitable times and upon request.

6. Monitoring arrangements

The school's arrangements for managing the access of education and training providers to students is monitored by Yusuf Khan, Careers Lead.

This policy will be reviewed by the Careers Leader and Deputy Head annually. At every review, the policy will be approved by the board of Governors.
